THE CORPORATION OF THE TOWN OF HANOVER

BY-LAW NUMBER 2003-06-20-94

BEING a By-law respecting the supply of water, the management and maintenance to regulate and control extensions, alterations or enlargement of water distribution of the Corporation of the Town of Hanover.

WHEREAS Section 12 & 13. of the Public Utilities Act, R.S.O. 1990 Chapter P. 52, enables Corporations to pass By-laws to regulate the supply of and to prohibit wrongful use of water.

AND WHEREAS it is in the interest of the Council of the Corporation of the Town of Hanover to enact a By-law to do so.

THEREFORE the Council of the Corporation of the Town of Hanover enacts as follows:

- 1. No person, except as authorized by the Council shall tap or make any connection with a watermain, or turn off or on, or interfere with in any manner, any valve or appurtenance of the water system.
- 2. No person, except as authorized by the Council, shall dump or throw any material into water reservoirs or open water channels or place any foreign material in any fire hydrant, water pipe or outlet of the Corporation.
- 3. The Corporation may order the suspension of all use of water through a hose, or other attachment for use on lawns, flower beds, streets or garden sprinkling, or for any other outside purpose whenever the use of water in a previous twenty-four (24) hour period exceeds the current capacity of the Corporation's water system. An order to suspend this use shall continue in effect until revoked by the Council, and shall only be revoked when the current capacity of the water system again meets or exceeds the safe level as determined by Council.
- 4. No person shall use water for lawn, flower bed, street or garden sprinkling, or for any other outside purpose whenever an order to suspend thereof is in effect.
- 5. The times for use of water, through a hose or other attachment for use on lawns, flower beds, streets, garden sprinkling, or any other outside purpose shall be:
 - (A) Those residents in the Town of Hanover with <u>even</u> home and dwelling <u>numbers</u> may use water on the even calendar days.
 - (B) Those residents in the Town of Hanover with <u>odd</u> home and dwelling numbers may use water on the odd calendar days.
- 6. The Corporation does not guarantee the supply or quality of water and failure to supply water of sufficient quantity or quality shall not be construed as neglect on the part of the Corporation.
- 7. Every person who contravenes any provision of this By-law is guilty of an offence and is liable to a fine of not more than \$2,000.00 exclusive of costs, recoverable under the Provincial Offences Act.
- 8. No action or proceedings under this By-law shall preclude the Corporation from or derogate from the right and power of the Corporation to exercise any other right or remedy prescribed in this By-law or elsewhere.

- 9. By-law 1622-09-08-87 and By-law 1761-3-5-90 is hereby repealed.
- 10. This By-law shall come into force upon the final reading thereof.

READ a first time this 20th day of June, 1994.

READ a second time this 20th day of June, 1994.

FINALLY READ a third time this 20th day of June, 1994, signed by the Mayor and the CAO/Clerk, sealed with the seal of the Corporation and engrossed in the By-law Book.
