5. **ITEMS FOR DECISION/DISCUSSION**

5.1 **Collection of Cardboard & Recyclables at the Hanover/Walkerton landfill site**

- Ron Cooper provided a report on extending the contract for the collection of cardboard and utilizing front load bins for comingle recycling at the Hanover/Walkerton landfill site.
- The contract extension was deferred pending further information.

5.2 **Expanded Polystyrene Recycling Service**

- The committee reviewed a proposal from Second Wind Recycling to provide monthly onsite polystyrene densification and recycling at the Hanover/Walkerton Landfill site and Walkerton Recycling locations.
The following motion was subsequently approved.

Moved by ED KING / Seconded by WARREN DICKERT

THAT the Hanover/Walkerton Waste Management Committee recommend acceptance of the proposal from Second Wind Recycling at a cost of \$10,000 per year commencing in December 2020 as a pilot project at the Hanover/Walkerton Landfill site and Walkerton Recycling Centre locations for polystyrene densification and recycling.

The committee discussed that large volume non-residential users be encouraged to setup contracts with Second Wind Recycling to provide densification at their own facility or provide a financial contribution for the program.

5.3 Bag Tag Fees

- The committee discussed the current bag tag fees for both Hanover and Brockton with the following motion subsequently approved

THAT the Hanover/Walkerton Waste Management Committee recommend to the Municipality of Brockton and Town of Hanover that the bag tag rates remain unchanged for 2021.

5.4 2021 Landfill Budget

- Ron Cooper provided the 2021 landfill budget which was deferred for further information.

5.5 Development Approval Requirements for Landfills (Bill 197)

- The committee reviewed a request from the City of St. Catharines to amend Bill 197 to eliminate the development approval requirement provisions from adjacent municipalities.
- The committee did not support the request and the correspondence was noted and filed.

6. ITEMS FOR INFORMATION/CORRESPONDENCE –

6.1 2020 Landfill Quantities

- The Committee reviewed the landfill monthly quantities to October 31st overall quantities reviewed has increased by 15.9% as compared to 2019.

6.2 Landfill Operation Report

- The Committee reviewed the landfill site operations report for September and October with no concerns noted or expressed.

6.3 Proposed Blue Box Regulation

- The committee reviewed the proposed Blue Box Regulation which is posted on the Environmental Registry of Ontario for public feedback to December 2nd, 2020
- It was noted that both Town of Hanover and Municipality of Brockton (though Bruce Area Solid Waste Recycling) transition year is 2025.

6.4 Cell No.2 Construction

- Ron Cooper reported that Cell No.2 was substantially completed on September 9th. Capping of the north side of Cell No.1 which was included in the tender has yet to be completed.

6.5 HHW Event – October 17, 2020

- The Household Hazardous Waste Event will be held on October 17th at the Hanover Public Works Yard had a total of 216 participants with 187 from Hanover and 29 from outside Hanover.
