**WHEREAS** Report PRC-05-20 — Hanover Recovery Centre Direction was presented at a Special Meeting of Council on October 13, 2020; and

**WHEREAS** Option C | Recovery Centre is Disassembled with Commitment to Reinstall if Required was approved by council; and

**WHEREAS** the Recovery Centre was disassembled and ice installed for community organization use with the understanding that should the Recovery Centre be required in the future, the ice would be removed and the Recovery Centre put back in place; and

**WHEREAS** on January 13, 2021, the Province of Ontario declared a second State of Emergency due to the threat of the collapse of the province's hospital system and alarming risks posed to long-term care homes as a result of high COVID-19 transmission rates; and

**WHEREAS** additional public health measures have been implemented including a stay-at-home order requiring everyone to remain at home with exceptions for permitted purpose or activities and as such the lockdown has caused the closure of the P & H Centre until at least February 11, 2021; and

**WHEREAS** the Medical Officer of Health and Chief Executive Officer, Grey Bruce Health Unit, is advising us of the need.

**NOW THEREFORE** be it resolved that council of the Town of Hanover direct staff to remove the ice at the P&H Centre and make the facility available for public health and pandemic response at the direction of the Grey Bruce Public Health Unit and that all groups and organizations affected be hereby notified.
