Industry & Business - Influential in the area of community economic development related to small and large business.

Community Service - A long serving community minded individual whose outstanding leadership, influence, direction, vision and dedication has made an impact at a regional, provincial, national and *I* or international level.

2. Personal Achievements and I or Accomplishments

Persons of extraordinary ability and dedication who have earned distinction by bestowing pride and honour on the Hanover community and themselves.

Politics- Elected Officials influential at a regional, provincial or national level.

Sports - Accomplished athletes.

Arts - Accomplished in the arts.

Recognition

- Inductees will have their name(s), accomplishments and applicable year engraved on a recognition paver and placed appropriately in the Labyrinth.
- Inductees will be profiled in the Labyrinth of Distinction Brochure.
- Inductees and their immediate family members will be invited to the planned Induction Ceremony.
- Inductees or their respective families shall receive an appropriate memento.

Procedure for Nomination

- Nominations shall be on an official nomination form and should include as much information as possible, outlining the merits of the nominee.
- Nominations will be accepted up to March 31st of the respective year of nominations review. Nominations may be made on an ongoing basis.
- A maximum of 2 inductees will be selected bi-annually by May 1st of the respective year, beginning in 2006.
- A ceremony to induct selected nominees will be included with Canada Day Celebrations, or another appropriate event should Canada Day Celebrations not occur.

Administration

The Labyrinth of Distinction is administered and managed by Hanover Parks, Recreation and Culture. On behalf of Hanover Council, the Parks, Recreation and Culture Advisory Committee shall:

- accept nominations for the Labyrinth of Distinction
- select and recommend to Municipal Council, inductees to the Labyrinth of Distinction
- host a ceremony to introduce inductees
