# 9.4. MHBC Planning Urban Design & Landscape Architecture re: Overview and Assessment (More Homes Built Faster Act, 2022)

The Secretary-Treasurer stated that the above documents is a cumulation for broader discussion.

Bill 23 *More Homes Built Faster Act*, 2022 was passed on November 28, 2022 and affects many Statues and Regulations. Many of the changes resulting from Bill 23 do not significantly impact the town, but predominately affect multi-residential development, third-party appeals, site plan control processes and changes amount of fees and charges that Municipality's collect to name a few.

The Town enlisted Dana Anderson of MHBC, Planning Urban Design and Landscape Architecture to prepare an overview of Bill 23. Dana will make a presentation to Hanover Council on January 16, 2023 to highlight the implications of Bill 23 to the Town.

The Committee generally agreed that staff complete a survey of other municipalities' fees for development charges and site plan control.

The Secretary-Treasurer highlighted the above referenced article whereby Saugeen Shores is exploring a Community Planning Permit System (CPPS) to combine zoning, site plan and minor variance processes into one application.
