- Oversee aquatic staff during shifts, including assigning tasks and directing the staff deck rotation schedule
- Communicate with staff to ensure all guiding requirements and patron-to-lifeguard ratios are met
- Ensure the accurate and timely completion of daily and monthly logs
- Respond to concerns and requests of patrons
